Job Title: Assistant Chief - Training

#### **BASIC POSITION RESPONSIBILITIES:**

The primary duties of this position shall be:

- Responsible for the efficient management and implementation of department EMS & FIRE training programs for career and volunteer staff members.
- Responsible for the oversite of the recruitment and retention program of all member classifications.
- Duties include administrative, supervisory, staff training, instructing, technical fire
  and emergency service duties at all levels encompassing emergency response,
  participate in Battalion Chief Coverage, hands-on fire ground, EMS, rescue
  activities and serve as Incident Commander when needed. This position shall
  serve as an example in teaching, coaching, and mentoring all personnel.
- Maintain physical fitness to perform arduous emergency scene duties.

#### JOB RESPONSIBILITIES AND TYPICAL DUTIES:

- Coordinate, research, plan and implement all department training programs related to safe and effective emergency services.
- Supervises the development of manuals, courses, classes, and other training methods used in the training development of all Chena-Goldstream members.
- Teach, coach and mentor career and volunteer staff members, and scholarships.
- Coordinate inter-department training activities with other departments and agencies.
- Assist with the development of policies, procedures, and guidelines for training, recruitment and health and safety programs.
- Assist the Fire Chief with the development, presentation, and justification of the annual budget for training, recruitment, and health safety program.
- Maintains and ensures the department's training records and fire reporting

- (NERIS/ANFIRS) data are correct and up to date.
- Shares the Battalion Chief responsibilities associated with emergency response.
- Develop and revise promotional testing and evaluation processes to meet the department's changing needs.
- May assist in the investigation of accidents and complaints to ensure adherence to department policies and procedures and performance standards.
- Regularly review staff performance levels and facilitates an interactive process to address any performance concerns at a company, division, or individual level.
- Writes and conducts employee performance appraisals.
- Capable of responding to emergencies during low staffing periods in any department position from firefighter to Incident Commander or ambulance driver to lead medic or higher.
- Attends, prepares, and presents progress reports of programs at the annual General Membership meeting.
- Supervises the development, planning, and implementation of Public Education programs.
- Attend department annual meetings.
- Acts as liaison for the UAF/CTC Fire Science Program
- Oversees the CGFR Scholarship program
- Oversee volunteer recruitment and retention.
- Counsels all levels of staff on operations and training
- Oversees promotional testing and personnel evaluation processes to meet the department's changing needs.
- Assumes the position of Incident Commander during emergency operations.
- Coordinates activities with other departments and agencies
- Other duties as assigned.

## **MINIMUM QUALIFICATIONS:**

Submit documentation with application to verify minimum qualifications.

- High School diploma or equivalent
- Associate's degree in a general professional or technical field. Experience may be considered in lieu of education.
- Minimum of ten (10) years or Fire and EMS emergency service experience.
- Experience with a volunteer or combination fire department is preferred.
- It requires a comprehensive background investigation, including a local, state, and federal criminal history check and sex offender registry check.
- Valid Alaska driver's license
- Must meet insurance standards and maintain insurability under the Department's policy.
- Certified IFSAC/ProBoard Firefighter I
- Certified IFSAC/ProBoard Firefighter II
- Certified IFSAC/ProBoard Fire Instructor I or the ability to obtain within one (1) year (FSI II preferred)
- Certified IFSAC/ProBoard Fire Officer I (FOII preferred)

- Current EMT-3A, AK-AEMT, or paramedic certification or the ability to obtain within one (1) year
- I-100, I-200, I-700, I-800 certificates (I-300 and I-400 at the next offering if not already)
- Certified IFSAC Fire Apparatus Driver/Operator (FADO): Driver/Pumper Certification or the ability to obtain within one (1) year
- Certified IFSAC Fire Apparatus Driver/Operator (FADO): Pumper Certification or the ability to obtain within one (1) year
- Certified IFSAC Fire Apparatus Driver/Operator (FADO): Mobile Water Supply Certification or the ability to obtain within one (1) year
- Current BLS Provider certification
- Current BLS Instructor certification or the ability to obtain within one (1) year
- Rapid Intervention Technician documented training (preferred)

## **REQUIREMENTS TO PERFORM WORK:**

- Alaska Fire Standards Council and Bureau of Fire Accreditation, Standards and Training (BFAST) role and services available to the training division of fire departments and the training program audit process.
- Insurance Services Office (ISO) evaluation criteria for fire department training.
- Fire Department training requirements and instructional needs.
- Safety principles and practices of fire suppression and prevention.
- The safe use and maintenance of firefighting equipment and apparatus.
- Local geography, cold weather operations, and resources of the fire service area.
- Patient care in rural environments and off-road rescue operations.
- Firefighting equipment and apparatus
- Promotional processes.
- Applicable laws, regulations, city, borough, department policies and procedures, and quality and safety standards.
- Annual and long-range training plans.
- Local, state, and federal laws relevant to personnel matters.
- Procurement processes
- Fire Department data and record management system.
- Incident Command System staffing needs during emergencies and nonemergency events.
- Public Safety Record Management System software.

## Ability to:

- Ability to write comprehensive reports and to verbally communicate effectively.
- Demonstrate competency in the use of computers (MS Word, Excel and PowerPoint are required), simulators and other education and training equipment technologies.
- Demonstrate progressive, innovative, creative methods of supervision and instructional delivery.
- Must have the ability to work independently of direct supervision.
- Demonstrate the ability to prepare formal oral and written reports clearly and concisely.
- Demonstrated ability to establish and maintain effective working relationships with management, coworkers, federal and state officials, public and private groups.
